Definitions

User – any person who uses this web resource without prior registration

Participant – a user who has registered on the website of Planet Mobile <https://ico.planetmobile.net> and has accepted public agreement and, by affixing appropriate tags, has consented to adhere to rules and policies of the operation of Planet Mobile web resource.

Project – Planet Mobile

Token – in understanding and for the purposes of the functioning of this web resource, a token is understood to mean exclusively a utility token, which is a digital coupon (a certificate of prepaid service) that gives its owner the right to receive in exchange a set of services or goods.

Registration – entering the designated personal data by the user of the web resource of Planet Mobile to obtain the status of the participant and for creating a personal account that allows to personify such a user.

Account – for the purposes of this resource, a term designating an electronic register of record units that have identification and quantitative qualities.

1. General Provisions

- 2.4. As a result of the registration procedure, the user receives an email with activation. The time of receipt of such an e-mail depends on the provider of Internet services and technical parameters of the user's electronic device.
- 2.5. After following the activation link, some information about the user will be requested, for the purpose of identification within the framework of KYC (know your customer) generally accepted requirements.
- 2.6. The data provided by the user is accepted on the basis of the "good faith" principle and all responsibility for the veracity of the provided data is assigned to the user. If false information is specified, the user may be denied for further use of this web resource and its services.
- 2.7. After passing the above mentioned procedure user can use the web resource for his own purposes.
